#### **About Your Statement**

#### **Statement Period**

If the Charge is in U.S. dollars, it will be converted directly into Canadian dollars.

Unless a specific rate is required by applicable law, you understand and agree that the American Express treasury system will use conversion rates based on interbank rates that it selects from customary industry sources on the business day prior to the processing date, increased by a single conversion commission of 2.5%. If Charges are converted by third parties prior to being submitted to us, any conversion s made by those third parties will be at rates selected by them.

#### **Delinquency Assessments**

Delinquency assessments accrue and are calculated at the rate of 0.0822% (equivalent to an annual rate of 30%) of each Delinquent Charge for each day that the Delinquent Charge remains outstanding, starting from the date of the billing statement on which the charge becomes delinquent. #### **Billing Errors**

If there is an error or omission in this statement you must notify us in writing within 25 days of the date of this statement. If you do not do so, the statement will be conclusively settled to be complete and correct except for any amount which has been improperly credited to the account.

A payment made using Pay by Online Services may only be scheduled within 28 days after the date of your most recent statement. However, payment must be made by the date required for your Card. Payments made by you via your financial Institution will not be credited until received by us within 3 to 5 business days. Please check with your own financial institution regarding processing delays. Please make cheques or money orders payable to Amex Bank of Canada. If mailing your payment, please include the bottom portion of your statement in the enclosed envelope. A mailed payment may take up to 10 business days or longer to be received depending on your geographic location. It is your responsibility to ensure that sufficient funds are available in the deposit account. 
